Rules and Regulations

1. JUST HAVE FUN! Don't take the competition too seriously! This is an event to rival the spirits of BBQ!
2. All food must be cooked on-site, except desserts. Food cannot be sold to the public at anytime.
3. Entry fee of \$30.00 allows entry into all three categories if contestant chooses. Competitor must enter at least one competition.
 - Pork
 - Poultry - includes chicken and Cornish hens only
 - Ribs - must be on the bone
 - Dessert
4. Contestants can begin set-up and cooking at 6:00 am, Friday, July 1, 2011. No earlier arrival times will be allowed. Cooking shall not begin until the competitor is registered. No pre-seasoned meats will be allowed.
5. Judging will begin at 5:30 pm, Friday, July 1, 2011. Awards will be given out at approx. 8:00 pm, Friday, July 1, 2011.
6. Contestant must bring ALL equipment needed for competition. Water will be available, but you will need to bring your own hoses and containers. All meats needed for competition must be brought in by contestant. Ice will be available for a small fee.
7. Contestant will be given a 10'x15' space for competition. Each contestant must stay within given space. No encroaching on other contestants' space. No sharing of spaces is allowed.
8. No electricity will be provided. Plan accordingly.
9. Fires will be of wood, wood pellets, or charcoal. Gas or electric grills are not permitted for the competition. Deep-frying is not allowed.
10. Entries will be submitted by blind containers. Containers will be provided. Turn-in times for judging will be given in more detail the morning of registration.
11. Safety rules for competition:
 - NO use of tobacco products in cooking space
 - Cleanliness of space is required; a bucket of bleach water must be present in space for cleaning
 - Shoes and shirts must be worn at all times
 - Before cooking, meat must be kept at 40 degrees or less, and packed on ice
12. If you have competed in any KCBS professionally sanctioned BBQ competition in the past 12 months or won a professional category in the past 36 months, you may not have an entry in the Squealin' on the Square presents "Bacon in the Sun" competition.
13. All contestants must have cleaned space and evacuated by 11:00 pm, Friday, July 1, 2011.

Anyone found not in compliance with the rules above will be disqualified from the competition, and from future competitions in Freedom Fest. The decision of the judges is final. No refunds will be given due to weather or unforeseen circumstances.
